

Recognised Certification Labels for the Green Button

(02/2023)

As part of the meta-label approach, the Green Button sets requirements for production processes. Companies demonstrate compliance through recognised certification labels. An independent assessment (benchmarking process) is currently taking place to evaluate which certification labels are recognised for complying with the requirements of Green Button 2.0. The certification labels recognised for the Green Button 1.0 are provisionally recognised for the Green Button 2.0 until July 31, 2024. These certification labels are marked with the white box. [GB1.0]

The green box [882.0] indicates which certification labels are already recognised for the Green Button 2.0.
